## President's Message

A restriction of limiting each member club to a maximum of three championship events resulted in a 2011 calendar of fifteen races. Three member clubs elected to run multiple race weekend events with NWMS breaking new ground by offering three races on a single long weekend. This resulted in eleven race weekends.

There is a financial argument for clubs to explore multiple race weekends, and there appears to be some support from some of our membership for more races on fewer weekends. The economy continues to challenge our entrants and our clubs.

The Pacific Northwest and ICSCC are blessed with 5 road racing circuits and a new venue is scheduled to debut in 2012, while rumours and plans hint of more to come. We have survived the closing of race tracks in the past (Westwood, Western Speedway, Tacoma, Port Orford, Deer Park, to name a few), so the anticipation of expansion is exciting. However, the unregulated growth of ICSCC could challenge our future if we are unprepared. Can our current championship requirements and by-laws incorporate the inevitable expansion that these new venues and new clubs will bring? Now is probably the time to form a committee to explore the options.

A distressing direction was adopted by ICSCC this year with the adoption of a policy making the e-board fully responsible for the approval of all racing venues. This could become a concern dependant on if, how, and when these new tracks come on line. We have not adopted any engineering or operational criteria for circuits to meet, or to maintain, throughout their tenure with ICSCC. Ironically, the strength of Conference over our 55 years is that the policies and rules have been well documented and available for all to reference. Safety has always been at the forefront of those policies. We are now in a position of uncertainty with regard to track

approvals. Not only because our future boards have no engineering guidelines but also because they will always be in a conflict of interest position due to their contractual relationship with their home tracks.

The transparency of how our regulations are formulated has been lost. It is this transparency which has led to the level of trust that the e-board enjoys today. When you examine the documentation available from other track approval organizations (i.e. FIA Standards), you quickly realize that the scope of compiling and keeping current this information is beyond ICSCC's abilities. This year, even with the knowledge base, research, and enforcement of the FIA and NASCAR, we witnessed the death of two professional racers at professional race events. Our sport is and will always be dangerous. We owe it to ourselves, both morally and legally, to be making use of the qualified experts in our field.

Thank you to all our members for giving me the opportunity to direct ICSCC over the past three years and to the outstanding officers who have made the year happen. After forty plus years as a member of the conference I continue to be extremely proud of what we represent and confident of our continued success. Leslie and I have enjoyed traveling to all the races and meeting with everyone. We are looking forward to returning with our racing team.

- Karen McCoy – patient, cheerful, and easy to work with.

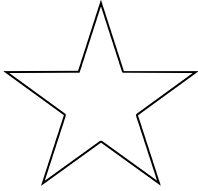
My wife Katie – a supportive spouse if ever there was one.
