ENDURO CORNER

By the time you read this, all of the one hour races will have been completed. Only a two hour race for **double points** remains. As I write this, the point championships are far from being clinched. ME0 is separated by 6 points, ME1 by 10, ME2 by 4, and ME3 by 9. And now there will be dropped races that come into play which may further close the gaps in some of these tight championship races!

So let's turn our attention to the series finale and the 2015 Festival of Endurance at PIR. As most of you know, the Cascade Festival of Endurance takes place Saturday, October 17th and encompasses three separate races. The first is the 2 Hour Northwest Mini Enduro Series Finale. One thing to remember about the 2 hour race is that Sports Racers are eligible to enter in the MSR class. And as I mentioned earlier, this race is worth double points in the championship. The 2 Hour race is a standalone race, utilizing a rolling start. It runs from 10:00am to Noon. After a one hour break, the final two races in the festival begin. The ever popular LeMans start begins these two races!! The first race is the Casa Bella 300. Casa Bella (a Portland granite and marble store) is sponsoring the 300 mile (156 lap) race. Each car entered in the 300 mile race will actually race until they complete 156 laps. The first car in each class to reach 156 laps is the winner; the second to reach 156 laps is 2nd, and so on. Most cars will be able to complete the race in 3.5-4.5 hours so darkness shouldn't be a factor. The final race that makes up the "Festival" is the 8 Hours of the Cascades. The 8 Hour starts in the daylight and ends in darkness! The LeMans start and the nighttime racing makes this race a popular one for many. The event is set up where a team can enter any combination of the three races in the Festival.

For those diehard endurance people, the "Iron Team" award was created. To be eligible for the Iron Team award, a team must enter all three races. Each team will be awarded points in all three races. There are "base" points and "bonus" points. I won't go into great detail here, as the rules are available online, but the overview is this: Depending on where you finish in class, base points are awarded $(12 - 1^{st}, 10 - 2^{nd}, 9 - 3^{rd}, \text{etc.})$. On top of the base points, bonus points are awarded (0.5 points per number of cars in class). A quick example: There are 6 cars in E1 for the 2 hour, 5 cars in E1 for the 8 hour, and 4 cars in E1 for the 300. Car "X" is entered in E1 and wins the 2 hour, places 2^{nd} in the 8 hour, and places 3^{rd} in the 300. Points are awarded as follows: 15 pts (12 + 3) for the 2 hour, 12.5 pts (10 + 2.5) for the 8 hour, and 11 pts (9 + 2) for the 300 for a total of 38.5 points. The team that accumulates the most points in the three races will be crowned the "Iron Team Champion" and winner of a unique trophy plus a **FREE 2016 CSCC October enduro entry**. If there is a tie, the team that completes the most laps will be crowned the "Iron Team Champion".

The 2015 ICSCC racing season is nearing its end, but with up to 10 hours of racing on this Saturday in October, there is still time to team up with family and friends to share a day of active and spirited competition!!!
