### FROM THE PRESIDENT

ello all and welcome to the ICSCC 2020 racing season!

As I write this the "covid-19 global pandemic" is causing extreme reactions among our overly invasive politicians dabbling at suspending our Constitutional rights and the hyperactive media seemingly trying to convince the common sheeple they are in the middle of an "extinction level event". I'm going to spare you any further opinions from me on that subject but as a Conference officer it is important that you know our member's health and wellbeing is very important to us. I hope that during the next few weeks there is a better understanding of the virus and some of the more draconian restrictions are lifted. The beginning of our race season is about seven weeks away and it is my hope that we will return to some degree of normalcy and escape the wave of cancellations and restrictions we are seeing on current events. We will be monitoring the situation closely and keep you informed. In other words, take common sense measures, stay well just like always and don't get behind on your car prep!

This years Spring meeting was busier than many in the recent past. You, the Driver Members of Conference, sent your representatives and they are doing their best to give you the changes you want both for better racing and sustain ability for the organization. The highlights include:

The creation of an Enduro only license. In an effort to attract people who have documented amounts of track day training, other forms of motorsports participation, and/or budget endurance style experience we have created a limited "Enduro only" license. Anyone who can prove 4+hours of applicable track experience, pay \$25 per year, fill out the application and get approval from License Director Steve Clinton will receive a limited license that allows them to participate in any ICSCC Enduro that lasts 1 hour or more. No physical or club membership is required as with an ICSCC senior license. The holder of an Enduro only license cannot enter any of the regular ICSCC Championship races during the event and is not allowed a vote at the end of the year on rules proposals. It does offer

the license director an opportunity to assess them during the enduro and could be a pathway to qualifying for a Senior license. Think of it as a fine opportunity to enter your car in the enduro many of the clubs hold at the end of the day Saturday and bring out a friend who has adequate trackday or budget enduro experience to share your car. Urge people you meet who meet the qualifications to give Conference a try. It could be a lot of fun for you and introduce new drivers to Conference that might turn into future Senior license holders!

Double race weekends. The E-Board representatives have been saying the Driver Members want more racing and less practice. To that end, all races to be held this year are now multi-race events. For IRDC, Cascade, and SCCBC a race weekend will be comprised of a qualifying session and a race on Saturday and a qualifying session and a race on Sunday. NWMS in Spokane is set to hold their traditional three races on three days Friday through Sunday. Team Continental is still on hiatus developing their time trial program. That means a 17 race season over eight weekends and your best 12 results will count towards your championship total but only your best four from IRDC and Cascade and your best three from NWMS and SCCBC can be counted.

New rules voting. A big change! All of your club's votes used to be applied to whatever the majority voted for at your club rules change meeting. That meant that if 12 of the 136 total Driver Members of the IRDC showed up and 7 of them voted in favor that went forward to the Contest Board rules meeting and all 136 votes were presented in favor. With this years rule change we are trying to get members involved in their clubs again. Only votes from those present at the rules meeting and legal proxies will be counted and in proportion. For the example above IRDC would bring 7 yes and 5 no votes to the Contest Board rules meeting. You need to participate to maintain your club's influence!

Lastly – you already know that Duane Martinsen is your Steward for this year but I would like to thank a previous Steward, long time racer and mentor to many for stepping

up as Assistant Steward – Rick Delamare!

would like to welcome everyone back from the off season. First, I'm going to cover some of my race history for those that do not know me. I started out auto-crossing a late model Chevrolet Corvair in the early eighties. I did that for many years and helped start the Kitsap Kup series that BSCC still runs in Bremerton. Then I moved on to racing personal watercraft both stand up and sit-down models. If you really want to feel exhausted try an ocean race with 4-5' swells. Anyways then I moved on to racing with Conference in 2008 going through the Greg Miller school of high-performance driving. From there I have raced every season in either group 2 or group 5 using different variations of an RX-7. I have also been an assistant steward under M. Conature, T. Overdiek and last year S. Morton. That brings me to introducing this year's assistant steward who is Rick Delamare. Rick has been racing and associated with Conference since the 1990's. experience on the first couple of races is expiration dates. The two big ones are with helmets and seat belts. Make sure your helmet has at least the SA2010 rating or the newer SA2015 model. Check over your belts and ensure the expiration or manufacture labels are still attached. A more through explanation can be found in the Conference Competition rule book located on the Conference website under rule 1105.B.

As some of you may already know our RATS meeting was cancelled due to COVID-19 concerns. We will have to see if it can be rescheduled or have information passed in another method. This is also when we would have passed out materials like Competition Rules and P&P books. We are working on another method to get those out to the local clubs

I can't wait for the racing season to start and I will see you then.

## Team Continental Supplemental Regulations 2020



- 1. Any Driver, crew, spectator, transport driver, or attendee displaying unsportsmanlike, vulgar, or aggressive conduct toward TC, ICSCC, or ORP staff, will be dismissed from ORP along with the team for the weekend by the direction of either the event chairman, ICSCC steward or both. <u>Unsportsmanlike</u>, aggressive, and vulgar personal conduct directed at any race staff will not be tolerated during the race weekend.
- 2. Registration will be held at ORP Administration Building near Pregrid;
- 3. Family and Crew members with questions are to contact Driver Services at ORP Administration Building.
- 4. Due to extreme fire danger, smoking is permitted only on paved or gravel areas. Extinguish and remove smokeables carefully and completely.
- 5. Event announcements will be made on FM radio channel 100.1 and/or a PA system. Please be prepared.
- Team Continental reserves the right to refuse entry to this event or to ORP at any time.
- 7. Participants under 18 years old are not allowed in hot pits. Children under 12 require direct adult supervision at all times.
- 8. A current and properly completed minor release form, signed by an authorized adult, must be on record for all minor participants at ORP.
- 9. No skateboards or scooters allowed in the paddock area. Users of bicycles and small motorized vehicles may have riding privileges revoked at any time. Per ICSCC 1606. Motorized vehicles A. Motorized vehicles, including racing cars, shall not be driven in the pit or paddock areas by persons not having a valid state or provincial driver's license. Per ICSCC 1603. C. Children under twelve years of age may remain in the paddock area only under the direct, active and continuing supervision of an adult. No bicycles are allowed in the racing pit area except as they may be used by Race Officials. Bicycles may be operated in the paddock area by persons 12 years of age and older.
- 10. Refueling not allowed in Pregrid. Fueling in the hot pits requires a crew member assigned only to operate a fire extinguisher.
- 11. Pit and Pregrid roads must remain clear.
- 12. Pit lane speed limit is not to exceed 25 mph, pit lane speed zones will be marked with double cones at the entry and exit of pit lane.
- 13. Damage to ORP grounds, equipment or structures regardless of cause, will be charged to the driver responsible. Also, damage to any equipment or devices used by the sanctioning body (ICSCC) or sponsoring club (TC) to conduct this race, regardless of cause, will be charged to the driver responsible.
- 14. It is recommended you have access to a sealable container capable of holding 2 gallons of liquid. These are to be used to remove all oil, cleaners, brake fluid, etc. from ORP. There will be no drums provided.
- 15. If entries exceed the number of cars allowed on the track for a particular event, drivers and cars entered as an additional entry will be restricted from participating based on the date entries were received. This is in order to allow participation by all drivers for whom the event is their primary event, including Novices upgrading to a championship event.
- 16. NSF checks will be charged an additional \$50 fee.
- 17. Potable water, electricity and cell phone service may be limited or non-existent. Verizon wireless customers typically have coverage, but this is no guarantee of signal.
- 18. Pets must be leashed at all times and owners are responsible for cleaning up waste.
- 19. All in-car timing system transmitter beacons will be placed at a location designated by the Event Chairman.
- 20. Pit-out blend line violations will be dealt with by the Event Chairman, Driver Coach or Safety Steward.
- 21. The 5-minute warning may be given earlier than 5 minutes before the scheduled session start. But not more than 9 minutes before the scheduled start.
- 22. All race vehicles towed from the track may be dropped off at impound.
- 23. Additional supplemental regulations may be included in your registration packet...Please be prepared.
- 24. Anyone entering the ORP property agrees to allow TC to disclose any information held by TC about yourself should an ICSCC incident report be required for damage or injury. TC will release any and all information, should it be required, to ICSCC, ORP, and or PMM LLC upon their request for insurance purposes only.

Races are one hour or two hours in length. Two hour races count as two races (single points times 2). Note: Time does not stop for black flags or red flags

Top 7 races count towards the points championship. Must enter a minimum of five races in order to qualify for the championship. With three 2 hour races, there are a total of 11 races.

Each one hour entry shall consist of one or two drivers. Each two hour entry may have no more than four drivers. Drivers may drive in up to two cars per race.

Each one hour race will require a mandatory 60 second pit stop. Each two hour race will require a mandatory two minute pit stop.

Entry fee, qualifying procedure, etc. will be determined by sponsoring club and may be different between events.

Classes: ME0 – AP, SPO, SPM, GT1, GT2, GT3, ITE, ST, SST, P0

ME1 – BP, EIP, FIP, GTL, RS, AS, SE46, SPU, P1

**ME2** – CP, DP, PRO3, ITS, PRO44, HIP, CT4, P2

ME3 – EP, FP, GP, CR, PRO7, SM, CSM, HT, ITA, ITB, ITC, P3

MSR – SPORTS RACER CLASS (Open to ICSCC eligible Sports Racers)

Production classes (P0 – P3) – Open modifications as allowed per ICSCC Competition Regulations. Cars are classed by horsepower (HP) and weight to horsepower (WT:HP). If horsepower and WT:HP are in different classes, the Race Steward shall determine class. P0- 225 to 275HP, 10.0-12.0 WT:HP; P1- 180 to 225HP, 12.0-15.5 WT:HP; P2- 135 to 180HP, 15.5-19.0 WT:HP; P3- below 135HP, above 19.0 WT:HP. HP is determined using a Dynojet dynamometer 248/224/424 utilizing standard practices and procedures as described in the ST rules and as outlined in Section 1324.H of the ICSCC Competition Regs. A dyno form is not required. WT is minimum race weight with driver. Cars in Production classes (P0-P3) using tires with a treadwear rating of 180 or higher may move down one class. All other classes listed follow ICSCC rules.

**Points:** 1<sup>st</sup> – 12, 2<sup>nd</sup> – 10, 3<sup>rd</sup> – 9, 4<sup>th</sup> – 8, 5<sup>th</sup> – 7, 6<sup>th</sup> – 6, 7<sup>th</sup> – 5, 8<sup>th</sup> – 4, 9<sup>th</sup> – 3, 10<sup>th</sup> & lower – 2, Pole – 1 (where applicable / No pole points for 2 hour races). All positions are scored except as noted: DNF/DNS score a maximum of 6<sup>th</sup> place points. Number of laps completed will determine position for DNF's. All DNS's score the same number of points based on the number of cars in class.

Championship trophies will be awarded to class champions in classes that average 0.75 entries. Championship trophies will be awarded to the top 3 in classes that average 5 entries.

**Eligibility:** Licenses – ICSCC IRR / ENDURO, SCCA, CACC, SOVREN, FIA, ASN, or NASA. All other licenses must be approved by the ICSCC License Director. Novice license holders are not eligible.

### **FULL SET OF RULES:**

Entry to this race does **not** have to be in conjunction with any other race(s) of the weekend.

Except as noted, the 2020 ICSCC Competition Regulations will apply.

Classes follow ICSCC class rules except for the Production class (P0-P3) which is not an ICSCC class. Production cars should resemble factory production cars and shall follow guidelines outlined on page 1.

Maximum number of drivers per race: 1 Hour Races – two. 2 Hour Races – four. Teams may petition the Race Steward to have additional drivers. Drivers on teams that use more than the maximum number of drivers will receive full points if the driver has driven a minimum of fifteen minutes. Drivers may drive in up to two cars per race.

Car numbers will be assigned on a first come, first served basis.

**Points:** See above (page 1) for point structure. Each driver will receive the same points whether an entry is one or multiple drivers. Example: If a one driver entry wins – 12 points are awarded. If a two driver entry wins -12 points are awarded to each driver. Pole points will be awarded to both drivers. If a driver drives in two different cars in the same race, they will only receive points for the higher finish if the two cars are in the same class. If the two cars are in different classes, the driver will receive points for both classes. The Series Championship (each class) will be determined by adding a drivers seven highest point totals together. Ties in final points shall be resolved on the basis of each driver's record of first place finishes; then, if necessary, second place finishes. If two or more drivers have accumulated the same number of first and second place finishes, they shall be considered tied for the Championship. If for example two drivers tie for the Championship, the next driver shall be considered to have finished in third place.

**Mandatory Pit Stop:** Each one hour race will have a mandatory 60 second pit stop to be made between the 20 minute mark and the 40 minute mark of the race for both one driver and two driver entries. Each two hour race will have a mandatory two minute pit stop to be made between the 30 minute mark and the 90 minute mark of the race for both one driver and multiple driver entries. Pit stops may be made before or after the mandatory pit window but will not count towards the mandatory pit stop. The car's ignition must be turned off while refueling as well as when a driver change is taking place. All crew members who have the potential to come into direct contact with gasoline or gasoline vapors during pit stops are required to wear the following safety gear: A fire suit, fire resistant gloves, head sock, and helmet. A fire bottle designee is also required in case of a fire; however, they are not required to wear the same safety gear. No contact with the car is allowed while refueling except for a driver change. Helping a driver get belted in, radios plugged in, and cleaning the front windshield are not considered contact with the car and may occur at the time of refueling if necessary. Pit crew attire: Arms, legs, and feet shall be fully covered.

> The Pit lane speed limit and zones shall be determined by the sponsoring club. One crew member is allowed over the wall to signal the car into their pit space. During a Full Course Yellow (FCY), pit lane will be closed. If you are in pit lane at the time of a FCY, you will be released to rejoin the field. Pit lane will not re-open until the entire field has passed start/finish after the re-start of the race. If a FCY or Black/Red flag extends past the mandatory pit window, two green flag laps will be added to the pit window. The clock will continue to run under race stoppage.

**Minimum Penalties:** Pit lane speed violation, fuel spillage over 1 liter – Stop & Go. Improper attire on crew members over the wall, no fire bottle designee – Penalty Box: 30 seconds. Working on car during re-fueling – Penalty Box: 1 minute. Mandatory pit stop window violation: 2 lap penalty (1 hour races), 3 lap penalty (2 hour races). All others – Warning

**Trophies:** One or two in class  $-1^{st}$  only; three to five in class  $-1^{st}$  &  $2^{nd}$ ; six or more  $-1^{st}$ ,  $2^{nd}$ ,  $3^{rd}$ 

MANDATORY DRIVERS MEETING – See schedule. Failure to attend may result in starting at the rear of the field.

Each sponsoring club is responsible for setting the qualifying procedure. Qualifying sessions may vary from what is listed below. Check event schedule for the most up to date information.

### **QUALIFYING PROCEDURES**

ROUND 1 – MAY 2, 2020: Pressure qualifying. Either driver may qualify. Qualifying shall consist of one Green flag lap (one out lap and one green flag lap). Qualifying order shall be set by class with MSR first, then ME0, ME1, ME2, and ME3 last. The

starting grid shall be set fastest to slowest.

ROUND 2 – MAY 16, 2020: \*15 minute qualifying session. The starting grid shall be set fastest to slowest

**ROUND 3 – JUNE 6, 2020:** 15 minute qualifying session. The starting grid shall be set fastest to slowest

**ROUND 4 – JUNE 20, 2020:** 15 minute qualifying session. The starting grid shall be set fastest to slowest

**ROUND 5 – JULY 18, 2020:** \*15 minute qualifying session. The starting grid shall be set fastest to slowest

**ROUND 6 – AUGUST 15, 2020:** 15 minute qualifying session. Starting grid shall be set fastest to slowest

**ROUND 7 – AUGUST 29, 2020:** 15 minute qualifying session. Starting grid shall be set fastest to slowest

**ROUND 8 – OCTOBER 17, 2020:** \*Lemans start – No qualifying, no pole points

\* = No Pole Points (2 hour races)


