Steward's Soapbox

I'm pleased to be serving as Steward this year, and want everyone to welcome my assistants. Bill Spornitz and I have worked together at ProFormance for several years, and he'll make a great Steward next year. I've known Dave Bennitt through racing almost as long, and he'll be our technical Assistant Steward. I'm sure you recognize him from various IRDC events, where he's very active... when he's not under his car looking for an excuse.

With my first Memo column, I want to address an issue that came up over the Fall and Spring meetings, about safety belts. Lance Reichert, one of the BMW PRO-3 drivers, submitted a proposal about updating the language in Rule 1105.B to reflect current technology in materials, the width of belts, fastening systems, and installation techniques. His proposal included a packet that explained materials, belt manufacturers, certification agencies, and from other racing organizations which showed the modern state of the safety restraint industry.

Lance did a great job of writing up his proposal, and given his documentation I was able to re-write this rule book section to be clearer and representative of current technology. The new rule accommodates the change in manufacturing material from polyester to nylon. It allows for drivers using HANS devices to wear two-inch shoulder belts that are compatible with the devices. It also allows two-inch lap belts, which have become the standard in other safety industries because they reduce the chance for soft tissue damage, are just as strong as three-inch belts, and fit over the iliac crest in a shape that's safer during an impact.

I applaud your E-board representatives for passing the new rule, which I think is much safer and certainly much clearer than the previous rule. They did

require before accepting the rule that I make one change, however.

SFI certifies belts to last two years, but the FIA will certify belts for five years. In fact, FIA belts are marked with a date of expiry, while SFI belts are marked from the date of manufacture. The ICSCC Competition Regulations state that SFI-certified belts expire five years after their marked manufacture date. The SFI - and all other racing organizations we could find - expire the belts after two years.

While I and some of the other attendees felt that these rules were safer, the E-board pointed out that drivers would have to adhere to the newer rules without much notification of the change. We passed a rule that continues to allow the use of SFI-certified belts up to five years after their manufacture.

I don't think any drivers will need to buy new belts because of changes we've made to this rule. However, I do want to continue to refresh and clarify the seat-belt rules to reflect the best equipment that's available. The first opportunity to do so will be this fall, when I will propose a rule change for the life of SFI belts be revised to two years from manufacture. This will allow you - the drivers - the opportunity to amend the rule as you see fit with ample warning to plan for the next season.

I'm looking forward to a great season, and I'll see you in this column in the next issue.

SAFETY BELT RULE CHANGE for 2009

1105.B. Safety Belts. All cars shall be equipped with safety belts. Belts shall be worn while on track, in pre-grid, and while the car is under power in the paddock. Belts must meet all of the following design, certification, expiry, and attachment specifications.

- 1. Size and construction.** Seat belts shall be nominally two or three inches wide, metal to metal, quick release, nylon or polyester webbing material, aircraft-type competition style, with no buckle adjustment. Shoulder harnesses shall be at least three inches in width, quick release type. "Y"-type shoulder straps are not allowed. A driver may wear two-inch shoulder belts only when also wearing a HANS device.
- 2. Attachment.** Belts shall be attached directly to the chassis frame, roll structure, or equivalent structural part. Seat belts with eye bolt and snap type mounts will have snap mounts secured with cotter pins or safety wire. The installation, orientation, and location of the belts must meet the manufacturer's installation instructions for the application.
- 3. Certification.** All belts in competition use must meet SFI 16.1 or 16.5 specifications; or be homologated to FIA 8853/98 or 88534/98 standards. Belts must bear clear, un-modified labels indicating their specification compliance or homologation status.
- 4. Expiry.** Systems meeting SFI specifications include at least one label bearing the date of manufacture. These belts shall not be used after the last day of the fifth year after the date of manufacture. Systems meeting FIA specifications must have all belts labeled with their date of expiration, and these belts will expire on the last day of the year indicated on their labels.
- 5. Arm Restraints.** SFI or FIA-certified arm restraints are required and must be utilized in all open-cockpit cars including formula cars, and sedans with open targa tops, sunroofs, or T-tops.

ICSCC License Renewal Made Easy

Have you ever noticed the checklist at the bottom of the ICSCC Competition License Application? Or looked closely at your Memo label on the last and first issue of each year?

Make your life trouble-free — at least as far as re-newing your competition license — by following these simple tips:

1. Use the checklist — it works! Your license cannot be printed until the License Registrar has all those items. And if there's something missing your application goes to the bottom of the pile and the complete ones are processed first.
2. Look at the label on your Memo. If it says you need a doctor's physical, make an appointment with the doc now for early next year. Usually these appointments are difficult to get on the spur of the moment.
3. Send your application in early. Please don't wait until you're sending in your race entry to remember you need your new license. Besides, you could be charged an additional "hurry up!" fee.
4. Oh, and maybe the greatest incentive to plan ahead: If you wait until after March 31 to re-new, you could lose your favorite car number! Yikes!
5. And something new this year! If you usually read the ICSCC Memo online (or are willing to start), please check the box to opt out of receiving a copy by postal mail. Everything published in the Memo is available online — and usually about a week earlier than it arrives at your door. Once you have the license application documents in the mail to the License Registrar, Karen McCoy, it's probably a good idea to try to figure out what you want to get out of this coming racing season, and what it's going to take to get there.

Perhaps a pre-season plan might include some physical, as well as mental exercises, to shake off

The 2009 competition schedule is set, maybe now part of the season plan might include outlining a budget, which if you're like me consists of "how much do I have?"

It is also a good time now that the weather has improved, to take a critical look at the equipment. For instance, what items need to be replaced or upgraded as a function of service life or safety? Can you afford that Hans device or other SFI rated head and neck restraint now? Is the rest of your driver gear in good shape and not expired? Are your seat belt harnesses in good condition and not expired? How about the car itself?

If you're planning to rent this year, find suitable cars and initiate a conversation with the car owner about the terms and expectations.

The season opening event is the Driver Training event at Portland on Feb. 21st, and the NWERS 6 hour enduro is right around the corner on March 8th. It's a great time to get going on these things.
