



TC Supplemental Regulations 2010

October 2010

1. Registration & Express Tech will be held at the Oregon Raceway Park Administration Building:
Friday: 2pm to 8pm; Saturday: 7:30am to 3pm; Sunday: 7:30 to 10:30am.
2. Express Tech is available at Registration for those drivers who meet the following:
2.1 Completed entry form(s). 2.2 Prepaid in full. 2.3 No license issues. 2.4 Vehicle has a transponder and does not require a rental. 2.5 Have an acceptable Annual Tech inspection noted in their vehicle log book. 2.6 Not included in the mandatory Tech group for the weekend. 2.7 Express Tech drivers should bring their personal safety gear and vehicle log book to Registration, where gear will be inspected and a weekend tech sticker issued. 2.8 Express Tech eligibility is determined by the Registrar.
3. Paddock parking will be assigned.
4. Cars in PreGrid must be attended (to be able to be moved within 5 minutes for Life Flight).
5. Family and Crew members with questions are to contact Driver Services at ORP Administration Building.
6. Due to extreme fire danger, smoking is permitted only on paved or gravel areas. Please extinguish and remove smokeables carefully and completely.
7. Event announcements will be made over an FM radio broadcast and/or PA system. Please be prepared.
8. This event is organized under 2010 ICSCC Competition Regulations and all who enter ORP are subject to them.
9. Team Continental reserves the right to refuse entry to this event or to ORP at any time.
10. Participants under 18 years old are not allowed in hot pits, pre-grid or on victory laps. Children under 12 must have direct adult supervision at all times.
11. A current and properly completed minor release form, signed by an authorized adult, must be on record for all minor participants at ORP.
12. Competition numbers must comply with Section 1106 and will be strictly enforced.
13. No skateboards or scooters allowed in the paddock area. Users of bicycles and small motorized vehicles may have riding privileges revoked at any time.
14. Refueling not allowed in Pregrid. Fueling in the hot pits requires a crew member assigned only to operate a fire bottle. Excess spillage will result in a penalty.
15. Pit and Pregrid roads must remain clear.
16. Noise rule ICSCC 1112 enforced. 103 db at 50 ft.
17. Safety Belt rule ICSCC 1105B enforced.
18. Damage to ORP grounds, equipment or structures regardless of cause, will be charged to the driver responsible. Also, damage to any equipment or devices used by the sanctioning body (ICSCC) or sponsoring club (TC) to conduct this race, regardless of cause, will be charged to the driver responsible.
19. All entrants for this event shall present at tech inspection an empty, sealable container marked with the driver's name and license number, capable of holding 2 gallons of liquid. These are to be used to remove all oil, cleaners, brake fluid, etc. from ORP. There will be no drums provided.
20. If entries exceed the number of cars allowed on the track for a particular event, drivers and cars entered as an additional entry will be restricted from participating based on the date entries were received. This is in order to allow participation by all drivers for whom the event is their primary event, including Novices upgrading to a championship event.
21. NSF checks will be charged an additional \$50 fee.
22. Staggered start and split start requests shall be submitted to the Race Steward no later than the end of on-track activity on the day previous to the race.
23. Potable water, electricity and cell phone service may be limited or non-existent.
24. Pets must be leashed at all times and owners are responsible for cleaning up waste.
25. All in-car timing system transmitter beacons will be placed at a location designated by the Race Chairman.
26. Turn one (1)/Pit-out blend line violations will be dealt with by the Race Steward.
27. The 5-minute warning will be given earlier than 5 minutes before the scheduled race start.
28. All race vehicles towed from the track may be dropped off at impound.
